Get to know the Chilean and Californian markets

Chile

With the launch of the National Green Hydrogen Strategy in November 2020 Chile has positioned itself as a regional front runner and ambitious actor in creating a green hydrogen economy. The ambition is to establish 5 GW electrolysis capacity before 2025 and be among the major hydrogen exporting countries in 2040. McKinsey has estimated the market size to above 430 billion USD in 2030 and a number of large project developers are currently working on establishing PtX capacity.

The huge amount of natural energy resources, especially solar and wind, as well as the vast territory gives Chile optimal conditions for producing and exporting green hydrogen at very competitive prices. The large number of international project developers operating renewable power plants in the country and the openness of the economy and energy sector to competition furthermore create an interesting business opportunity.

California

Although the American market is often seen as a slower moving market when it comes to industrial energy transition, several factors point to the US establishing itself as a potential hydrogen world leader. In 2021, the US Department of Energy launched the so-called Hydrogen Energy Earthshot, several green hydrogen projects were announced, and the Build Back Better plan offers additional support for the sector. hydrogen-based products.









In the US, California is poised to become one of the key states for hydrogen for several reasons: First, its abundance of renewable energy and associated potential and existing curtailment challenges. Second, its ambitious and supportive policies incl. a clean fuels standard, carbon pricing and net zero targets. Finally, its high representation of heavy industry – California is the seventh largest industrial emitter which presents a big off-take opportunity for replacement of fossil fuels with

Objective of the export promotion

The export promotion activities will introduce Danish technology providers to the local project developers through meetings, creating a direct contact with potential Chilean and American buyers and partners throughout the complete value chain. The main aim is to establish a dialogue between Danish providers throughout the entire value chain and project developers; however, it is the responsibility of the individual Danish companies to further conduct the dialogue bilaterally.

Activities

The export promotion consists of a series of virtual meetings, including:

- Pre-meeting with a detailed introduction to the Chilean and American (represented by California) PtX market, overview of the main project developers and pilot projects, and information about business conditions and the general energy market in Chile and California. The meetings will be arranged by the Danish Embassy in Santiago and Trade Council North America.
- Series of meetings with the largest project developers in Chile and California with planned activities in PtX, including presentation of priorities, investment plans and commercialization.
- The participating Danish companies will present solutions and expertise to the project developers in a direct dialogue, sharing contact details as well.
- A dossier with company information on the Danish companies will be shared with the Chilean and Californian project developers and stakeholders prior to the meetings, and a report with information on the local stakeholders concrete activities will be sent to the Danish companies as a preparation to the meetings.
