

Hydrogen and Power-to-X delegation to South Africa

Join the first ever Danish delegation to meet the South African green hydrogen industry. During a four-day visit you will meet key public and private sector stakeholders and get an overview of the hydrogen ambitions, strategies and potential in the beautiful Rainbow Nation.

South Africa is already a leading producer and user of fossil hydrogen, mainly through its heavy industry. The ambition is to stand on this and use the country's vast green energy resources, its big ports, geographical situation as well as access to raw materials, to become a leading player in the future global green hydrogen economy.

Development of the green hydrogen sector is both seen as an important tool in terms of national decarbonization and a just transition – as well as an opportunity for economic growth and job creation.

10 GW in 2030

At the political level, the ambitions have been followed up by a series of policy and regulatory initiatives.

In 2020 the South African Department of Science and Innovation presented a Green Hydrogen Society Road Map (adopted by cabinet in 2021), which set the ambition of 10 GW capacity by 2030.

This was followed up by the Green Hydrogen Commercialisation Strategy Green Hydrogen and the SA-H2 fund (2023), which aims to secure \$1 billion in funding raised directly in South Africa or via indirect channels. The Fund is a partnership of private and public enterprises, locally and globally.









Cooperation on hydrogen

The EU increasingly looks towards Africa, including South Africa, for investments in green hydrogen. Countries like the Netherlands and Germany are already very active on the South African scene.

Denmark and South Africa have a long-standing cooperation in the field of green energy. Combined with the South African ambition and plans, this makes timing ideal for show-casing Danish expertise in the field and meet with industry and government representatives to get familiar with the developing South African market for green hydrogen and its derivatives.

Join our delegation

The visit will start in Pretoria and move on to Cape Town. During the four-day stay, the delegation will receive briefings from South African government representatives, including at minister level, EU-representatives, energy experts as well as relevant industry actors, such as Sasol, Engie, Hive Energy and Phelan (programme tbc). All of these companies are big players, who are already active on the hydrogen scene in South Africa.

As part of the delegation to South Africa you will:

- Get an overview of the ambitions, potential and specific plans of the roll out of the South African green hydrogen economy.
- Meet key South African actors in the field of green hydrogen and its derivatives, including companies, ministers, EU-representatives, and energy experts.
- Get an opportunity to show-case Danish hydrogen solutions.
- Explore possibilities for joint projects and meet potential new partners.
